B. AFHK Updates

- a. **Updates National AFHK** – A reminder was provided regarding, National AFHK choosing Ohio as a pilot state to implement Game On! Which is an Ultimate Wellness Challenge for the 2008-2009 school year. The deadline for schools to apply is May 23, 2008.
- b. **Ohio** – Kelly provided an update on Sub HB 254 and a copy of the revised bill was handed out to those present. Kelly also discussed and encouraged members to look at the Bank of America and Hasbro grant opportunities that were in the funding section of the May Ohio AFHK newsletter. Kelly said she attach the May Newsletter to the minutes and send out to all members. If members wish to apply for either or both of these grants, please let Kelly know.

C. UPS Grant

- a. **2007 – 2008** – end of the year grant summaries are being returned with all of the established breakfast programs showing improvements. The new breakfast program summaries are also showing good increases in participation.
- b. **Phase Two of grant awards** – Kelly updated the group on round two grant applications. Bellevue City Schools has applied for breakfast program grants for their five elementary schools. The grant committee will be discussing these applications. Since the remaining grant money is not enough to fully fund Bellevue's grant requests, Kelly stated that a grant request was also sent to the Bellevue Selective fund on behalf of BCS along with copies of the grant applications in hopes of funding the breakfast programs fully. This would also help establish collaborative efforts within the Zone, which is a requirement of the UPS grant guidelines.

D. Committees:

- a. Grant Committee** – Kelly provided a description of the duties of the grant committee to those present. She asked if anyone was interested chairing this committee to please contact her. - b. Workshop Committee** – Kelly also provided a description of the workshop committees duties and again requested those interested in joining this committee or leading this committee to please contact her. The next meeting will be scheduled as soon as Kelly receives the grant guidelines for the 2008-2009 grant year.

Debbie discussed the idea of offering Nutrition Fairs throughout the zone similar to the ODE grant and training that some of the Highland School District staff attended. Highland offered two fairs at two of their elementary schools which were highly successful. Further discussion followed regarding this idea. The idea of offering a workshop which trained organizations and schools on how to implement a Nutrition and Physical Activity Fair within their communities and school districts was mentioned with many ideas and suggested. The Workshop Committee will discuss this idea at their next meeting. This meeting will be scheduled as soon as Kelly receives the grant guidelines for the 2008-2009 grant year.

- c. Zone Outreach** – Kelly asked for any member who could help with this committee to please contact her. Kelly is currently the only person on this committee. This committee's duties are to identify organizations and businesses within the Zone 10 communities who might be other sources of funding or who would gain from being part of Zone 10 or collaborating with Zone 10. Building Zone collaboration and outreach is part of the UPS grant guidelines and would benefit all parties involved.
